CONDITIONS OF HIRE

- Hire payments are to be paid in advance
- Concessional rates are given on some items of hire if extension of hire is required, but only if paid in advance by due date. Late returns will incur a penalty rate of an additional 50% of the normal hire rate which shall accrue until the equipment is returned to Little Ones On Fitzroy.
- If extension of hire is required, prior approval must be obtained from LOOF.
- The Hirer shall pay to LOOF the cost of repairing the equipment as assessed by LOOF if damage is sustained during the hire period and the cost of cleaning the same if cleaning is deemed by LOOF to be required.
- Hirer shall provide a valid credit card number to be held as security and will only be charged in accordance with Clause 2, 4, 7 and 10.
- Hire charges shall apply from the date the equipment is taken from LOOF premises until returned thereto.
- If the equipment is to be collected by LOOF at the end of the hire period, then the Hirer shall notify LOOF when the equipment is ready for collection. Until LOOF receives the said notice indemnify the equipment the hiring charges shall continue to accrue.
- A minimum hire period of 1 day is applicable to all equipment in accordance with LOOF's schedule of hiring rates.
- In the event of the loss or destruction of the equipment the Hirer shall advise LOOF immediately of such loss or destruction and shall pay LOOF forth with the value thereof shown on the schedule above
- The Hirer shall:
 - Use the equipment in a proper manner and only for the purpose and within the capacity or fitness for which it was designed, acknowledging that LOOF can give no warranty as to the said fitness for purpose.
 - Accept full responsibility for the safe keeping of the equipment and indemnify LOOF for all loss, theft or damage however caused during the hire period.
 - Accept full responsibility for and indemnify LOOF against all claims in respect of any injury to persons or damage to property, arising out of the use of the equipment during the hire period however arising.
- Notwithstanding any period of hire specified, LOOF may terminate this hire agreement:
 - At any time by giving the Hirer notice of its intention so to terminate.
 - Without notice if the Hirer shall commit any breach of the hire condition. Upon termination or expiry of the hire period LOOF shall be entitled to take possession of the equipment and for this purpose the Hirer irrevocably appoints LOOF it's agent and authorises LOOF to enter any land or premises upon which the equipment are then situated and agrees to indemnify LOOF in respect of any claims, damages or expenses arising out of any action taken under this condition.
